**Invitation for Bids**

**National Agricultural Laboratory Building Construction (MAFF-CW-2)**

1. The Kingdom of Cambodia has received a loan from the World Bank toward the cost of the Cambodia Agricultural Sector Diversification Project (CASDP) and it intends to apply part of the proceeds of this loan to payments under the Contract of National Agricultural Laboratory Building Construction (MAFF-CW-2).
2. The CASDP of Ministry of Agriculture, Forestry and Fisheries now invites sealed bids from eligible and qualified bidders of National Agricultural Laboratory Building Construction (MAFF-CW-2). The construction period is 12 months after contract signing.
3. Procurement will be conducted through National Competitive Bidding Procedures outlined in the Government's Standard Operating Procedures on Procurement for Externally Financed Projects/Programs.
4. This invitation is open to all qualified bidders from eligible source countries of as described in the Bidding Document.
5. Bidders attention is drawn to Sub-Clause 6.3 of the Instructions to Bidders (ITB) on the Qualification requirements. Qualification requirements include:
  - Average Annual Construction Turnover: The average annual volume of construction work over the last 3 years (2021, 2022 and 2023) shall be at least **USD 6,102,015**
  - Specific Similar Experience: *Experience as prime contractor in the construction at least **two** (2) contracts for works of nature and complexity equivalent to the Works with a value of at least **USD 3,051,007** within the last 5 years.*
  - Liquid Assets: *The minimum amount of liquid assets or working capital or credit facilities of the Bidder shall be **USD 1,017,002**.*
