The shortlisting criteria are:

- Experience operating in Cambodia at least 3 years in Development of website, web portals, mobile apps, and relational database design. Experience in agriculture and market information related is a high plus. Experience in design and development of large-scale web portal and database with large amount of users.
- Experience delivering or designing technical or specialized job on Website on Agricultural Marketing Information System-AMIS, Agriculture Statistics Information-ASI, Develop Data Collection Apps and conduct TOT.
- Consulting Firm's experience vis a vis the assignment TOR and Technical Assistance Provider is an asset.
- Experience managing at least two relevant contracts/projects with an international organization (i.e. UN agencies, World Bank, ADB, IFAD, bilateral donors, etc.).
- Country Experience and Permanent presence/local office
