## **Invitation for Bids** The Supply and Delivery of 2 Generators (MAFF-G-20)

- 1. The Kingdom of Cambodia has received a loan/credit from the World Bank toward the cost of Cambodia Agricultural Sector Diversification Project (CASDP), and it intends to apply part of the proceeds of this loan/credit to payments under the Contract for The Supply and Delivery of 2 Generators.
- 2. The Cambodia Agricultural Sector Diversification Project (CASDP) of MAFF now invites sealed bids from eligible and qualified bidders for the Supply and Delivery of 2 Generators.
- 3. Procurement will be conducted through National Competitive Bidding Procedures specified in the RGC's Standard Operating Procedures on Procurement for All Externally Financed Projects/Program, under the laws and regulations governing public procurement within the Kingdom of Cambodia, and in accordance with the Financing Agreement and Procurement Regulations of World Bank.
- 4. This invitation is open to all bidders.
- 5. Interested eligible bidders may obtain further information from CASDP-MAFF and inspect the Bidding Documents at the address given below from 8:00 AM to 12:00 AM and 2:00 PM to 5:00 PM, from Monday to Friday, except government public holiday.
- 6. Qualification requirements include:
  - (a) copies of original documents defining the constitution or legal status, place of registration, and principal place of business evidencing legal status in an eligible source country as defined in GCC Sub-Clause 6.1 of Bidding Document.
  - (b) In the case of a Bidder offering to supply goods under the contract which the Bidder did not manufacture or otherwise produce, the Bidder has been duly authorized by the goods' Manufacturer or producer to supply the goods in Cambodia;
  - (c) The Bidder shall furnish documentary evidence that it meets the following experience and financial requirements:
    - (1) The Bidder has satisfactorily completed at least two contracts for supply of similar goods in the preceding three years of not less than USD 80,000.00.
    - (2) The Bidder has completed contracts in the total cumulative amount equal to at least USD 320,000.00 in the preceding two years.
    - (3) that the Manufacturer of the offered goods, if a different entity from the Bidder, has experience of at least 3 years in the manufacturing of similar
    - (4) that the Bidder has availability of liquid assets through either:
      - access to a line of credit or cash in bank account of an

- amount at least USD 80,000.00, net of other contractual commitments; or
- (b). credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least 6 months after the deadline date for submission of bids specified in ITB Clause 21.
- (5) that the Bidder meets any additional qualification criteria listed in BDS.
- b) A complete set of Bidding Documents in *English* may be purchased by interested bidders on the submission of a written application to the address given below and upon payment of a non-refundable fee *35.00 US Dollars* or its equivalent in Cambodian Riel being *140,000.00 KH Riel*. The Bidding Documents will be sent by airmail for delivery outside of Cambodia and by courier for local delivery or may be collected in person at the discretion of the bidder. Other than payment of the non- refundable fee specified above, there shall be no other conditions for purchase of the bidding documents.
